

# 全運女籃金牌主帥 看好大灣區籃球發展 鄭薇期待香港組建職業隊征戰WCBA

## 全運熱話

剛剛落幕的十五運會和殘特奧會，留下了無數令人熱血沸騰的奪金故事和拼搏瞬間，廣東女籃在決賽中以弱對強戰勝四川隊、時隔8年重奪全運會女籃冠軍便是其中之一。帶隊征戰全運的廣東女籃主教練鄭薇接受《大公報》專訪，回顧全運之旅時，不時提及備戰訓練和比賽中全隊表現出的堅韌和拼搏精神。

另外，鄭薇認為香港女籃借助承辦全運會，未來會進一步強化與內地聯動，期待未來有一支來自香港的職業球隊出現在WCBA聯賽（中國女子籃球聯賽）中。

今年4月，廣東東莞新彤盛隊戰勝四川蜀道遠達隊女籃，時隔6年重奪WCBA總冠軍。之後，鄭薇帶領以新彤盛為班底的廣東女籃征戰全運會，面對以李夢、王思雨、韓旭等眾多國手為班底的四川隊，廣東女籃除了主場作戰，牌面上明顯處於下風。

### 廣東隊時隔8年全運封后

為此，鄭薇制定了周密的戰術計劃。從備戰初期開始，廣東隊就圍繞四川隊進行技戰術準備。她坦言，從內線高度和板樁深度來看，廣東隊均處於劣勢，因此全隊上下都抱着「以弱戰強」的心態去衝擊對手。

「只要能將比賽拖入相持階段，心理包袱更重的四川隊就有可能出現波動，屆時廣東隊就有機會抓住勝機。」鄭薇說，為此，教練組制定了三個針對性部署，第一是提升防守強度，第二是打速度，第三是發揮外線遠投的優勢。

決賽中，整場走勢和鄭薇的預料如出一轍，廣東隊正是憑藉頑強的防守、快速的攻防轉換和精準的外線投籃，成功限制了四川隊的發揮，最終奪得了冠軍。

廣東女籃全隊酣暢淋漓享受奪冠的喜悅，平日備戰顯得嚴厲的鄭薇，被隊員們簇擁着拋向空中。

「我為她們高興和驕傲，她們想拋就隨她

們去吧。」鄭薇說。

### 港隊對山西隊不落下風

另外，鄭薇觀察到，與往屆全運會相比，香港籃球隊在十五運會成績有長足的進步。比如，香港女籃成年組雖然未能小組出線，但與內地球隊的差距縮小了，輸贏的分差明顯變少了。男子22歲以下組，香港隊先後戰勝了四川隊和福建隊，獲得全國第九名。

鄭薇表示，十五運會的成功舉辦對推動香港和澳門的體育發展起到了很好的促進作用，讓港澳運動員能夠親身感受內地職業體育發展的速度。

她特別提到，在備戰期間，香港女籃曾來到廣東隊的訓練基地進行了一周的合練，雙方都從中受益匪淺。

對於香港籃球的未來發展，鄭薇提出了自己的建議。她指出，由於香港女籃目前並非完全職業化，球員需要兼顧工作，訓練時間相對有限。她希望未來能有更多的交流機會，並提出了一個更具建設性的設想：「香港有沒有可能將來能夠加入女籃聯賽（WCBA）？」鄭薇認為，如果香港能夠組建一支球隊加入WCBA，將極大地促進香港籃球水平的提高。同時，通過職業化，也能讓更多有天賦的香港球員看到機會，獲得更好的發展平台，從而使得粵港澳大灣區的籃球運動整體獲得大發展。
