# 英「閃電過三關」迎後脫歐時代

# 約翰遜父申法護照「我永遠是歐洲人」

英國和歐盟達成的脫歐貿易協議,在

歐盟火速簽署後,英國國會下議院前日亦 以521票贊成及73票反對,順利通過,並 在上議院三讀通過及英女王御准同意,最 後由首相約翰遜簽署生效,前後只花14小 時,令英國趕及在當地時間昨晚11時(香 港時間今日早上7時)脫離歐盟,步入後脫 歐時代。不過英歐去年平安夜才趕在過渡 期快結束前達成協議,新規定匆匆實施, 商界便警告英歐貨物清關或出現混亂,恐 令英國的食品和藥物供應受阻。

**公**翰遜帶領英國脱歐,其父親斯坦利卻因家族與法國有深厚關係,昨日表示正申請法國護照,希望 成為法國公民。斯坦利稱,他的母親在法國出生,外祖 母和外曾祖父都是法國人,「我也是法國人,現在只是 重申自己的身份,我對此感到非常高興。我永遠是歐洲 人。」

80歲的斯坦利曾擔任歐洲議會議員,在2016年英國 脱歐公投中支持英國留歐,他的妻子則與約翰遜一樣支 持脱歐。斯坦利強調英國脱歐後,與歐盟維持關係非常 重要。

英歐《貿易及合作協議》的正式文本長1,246頁,涵 蓋總值6,680億英鎊(約7萬億港元)的雙邊貿易額。約翰 遜前日強調,今次簽署協議將開啟全新篇章,讓英國與 歐盟實現主權平等,英國也將成為歐盟「最好的朋友和 盟友」,保持緊密關係。

#### 供應受影響 食品藥物料漲價

根據協議規定,歐盟成員國公民若在協議生效前居 於英國,便可在英國工作及生活5年,之後可申請永久 居留。英國政府網站指出,歐盟公民可提供登機證或護 照蓋印,證明自己過去6個月內曾在英居住至少1天,



便合資格申請未來5年逗留英國。不少歐盟公 民昨日入境英國,當中包括計劃今年前往英國 留學的歐盟學生,以便合資格繳付本地生學費 以及可申請學生貸款。

與此同時,英國約30%食物供應來自歐盟,從歐 盟進口的新鮮蔬果,更佔英國市場一半份額。英國 食品飲品聯合會 (FDF) 執行主席賴特指出,此前法 國因應英國變種新冠疫情而臨時對英封關,導致大量 貨車滯留英國港口,加上按貿易協議實施邊境貿易新 規定,英國的貨物供應勢必受影響,短期內食品及藥物 價格將上漲。

#### 清關新規實施 勢礙跨境運輸

英國政府及海關運輸協會(RHA)也警告,英歐邊 境今日起便會實施清關新規,物流供應商如未準備好相 關文件,將阻延跨境運輸。英國一間物流公司的負責人 霍利曼便表示,他不會在本周安排任何貨車過境,避免



因通關問題受阻。不過英法隧道營運商 Getlink 主管基 費認為,在聖誕及新年假期期間,雙方跨境貨運量減 少,相信英法隧道今日會運作暢順,不會出現日前的大 擠塞情況。 ■綜合報道

## 網購歐貨逾4000元 英人須付關稅



英國民眾寄包裹往歐盟,今後須填寫海關 申報表。

英國正式脫離歐盟後,英歐之間按照貿易 協議,將實施一連串新規定,其中英國消費 者首當其衝面對的措施就是關稅。英國政府 表示,國民若到歐盟國家旅遊期間購物,又 或在網上購買歐盟貨品,總值超過390英鎊 (約4,141港元) 便須繳付關稅,部分貨品 還須支付增值税和手續費。

在脱歐前,很多英國人會到法國加來 「一日遊」,順道購買免税酒類,但從今 日開始,免税產品數量有所限制,每人只 可免税購買42公升啤酒、18公升紅酒及4 公升烈酒。此外,英國民眾寄往歐盟的包 裹,寄件人從今日起須填寫海關申報表, 英國國民收取從歐盟寄來的包裏,亦要先 繳付關税。

英國政府發表聲明稱,「若單一貨品的價 值超過免税額,便須按貨品原價交税,而非 只支付超出的金額。」價值390英鎊至630 英鎊的貨品,須繳付2.5%關税,630英鎊以 上的貨品則按照貨品種類規定繳付關稅。

岡薩雷斯表示,今次達成的初步協議,將 作為歐盟與英國未來談判直布羅陀邊境安排 的基礎,期望雙方6個月內可敲定及執行最 終協議。資料顯示,每日有多達3萬人來往 西班牙和直布羅陀。

## 美向歐徵報復性關稅 涉飛機零件

美國與歐盟在過去16年來,一直因 雙方各自補貼波音公司和空中巴士而 出現貿易爭拗、歐盟早前獲世界貿易 組織批准向美方加徵關稅,引起華府 不滿,美國貿易代表辦公室前日宣 布,將向來自法國和德國的飛機零 件、部分葡萄酒及干邑白蘭地等歐盟 產品加徵關稅。

美國貿易代表辦公室指出,歐盟去 年11月不公平地計算向美國加徵的關 税,例如參考的貿易數據,選擇了貿 易量因新冠疫情而大幅減少的時期, 令歐盟得以徵收更多關稅,華府認為 歐盟需採取補償措施。貿易代表辦公 室指出,美方前日宣布加徵關税是為 了報復歐盟,但未有説明新規定何時 生效。

美國葡萄酒貿易聯盟主席阿涅夫表 示,華府的舉動只會令美國企業面臨更 艱難處境,很多餐廳和小商戶將難以繼 續營運,使大量職位流失,他呼籲候任 總統拜登就職後,盡快扭轉華府對歐的

### 拜登擬上任首日頒令 叫停特朗普「午夜法規」

美國候任總統拜登的團隊前日批評, 總統特朗普政府沒有在權力交接上充分 合作, 揚言拜登就職後會即時採取行 動,叫停現屆政府急推的「壞措施」。

候任白宮發言人普薩基透露,與現屆政 府的交接並不順利,「彼此的合作和溝通 未如理想,未覆蓋全部層面,妨礙我們獲

得所需資訊及準備工作。」普薩基強調雙 方缺乏合作,將耽誤下年度聯邦財政預算, 更不排除現屆政府趕在任期結束前,推出 更多要留待下屆政府才能生效的措施。

這類措施在美國政壇稱為「午夜法 規」,拜登陣營表示,特朗普政府的 「午夜法規」可能陸續有來,或破壞國 安等方面的政策,新政府將在就任當天 發出備忘錄,暫緩或取消這些法規。

普薩基形容這是新政府的慣常做法, 他指有關法規對國民生活造成重大影 響,他舉例假如勞工部推出新規例,方 便僱主將全職僱員轉為自僱人士,拜登 政府將凍結這措施。 ■綜合報道
