
羅霖與楊思琦皆是堅強女性

香港文匯報訊(記者 依江) 韓國經 紀公司SM娛樂昨日宣布EXO成員燦 烈正式以陸軍軍人身份入伍,因疫情關 係,確切入伍時間、地點皆不公開,公 司也未另行舉辦粉絲告別活動。燦烈僅 在社交媒體上傳戴着毛帽、口罩的照 片,向粉絲説「再見」,預計他的退伍 時間為明年9月底。

現年29歲的燦烈去年10月陷入風 波, 遭自稱女友的網友爆料他多次劈 腿、私生活混亂,當時經紀公司與其 本人皆未對此發表解釋,要求燦烈退 團的言論也一度甚囂塵上。他於4個 月後才在粉絲專用社群網絡公開道 歉,今次入伍也格外低調。
